Silver Birch with TPO is sited near the top of the drive, this was already in position with a TPO when we purchased the house in 2006 - as the tree is now a reasonable size the root is causing tarmac driveway to crack and is causing the kerbstone to lift on the edge of the drive. If left the damage will continue and will be irreparable / needing constant maintenance. Trunk circumference is roughly 24 inches and hopefully you will be able to see the damage in the photos, large tree roots are also visible in the front garden. Chris Kunesch from Cedardale did a site visit on 27/04/2018 and recommended removal subject to approval. His opinion was that the damage would only get worse. Would be happy to replant based on advice.
