**8. Calthorpe Park School Extension**

At the recent Calthorpe Park School exhibition on their expansion plans it was stated that Calthorpe had an agreement to use a large section of the proposed open space at the North end of the Grove Farm development. They seemed to be under the impression that parking would be available on the community site, which presumably would occupy the unallocated (on their plan) space at the Hitches Lane end of that field. This would be the site offered for the CVPC community building for which provision is made in the S106 document. Cllr Jackson advised them that any parking on that area would

be for the community building, not for school sports. The school expansion project is being overseen by Mark Saunders, Strategic Development Officer, Children’s Services Department, HCC [strategicplanningunit@hants.gov.uk](mailto:strategicplanningunit@hants.gov.uk) who agreed to consult with CVPC as the scheme matures
